BYLAW NO. 5680
STREET AND LANE CLOSURE BYLAW, 2023(1)

THE MUNICIPAL CORPORATION OF THE CITY OF MOOSE JAW ENACTS AS FOLLOWS:

WHEREAS subsection 13(1) of *The Cities Act* S.S 2002, c.C-11.1, provides as follows:

"13(1) A council may, by bylaw, provide for closing, selling, or leasing any street if:

- (a) the council determines that the street is no longer needed for use by the travelling public; and
- (b) in the case of a public highway that provides continuity to a provincial highway as defined in *The Highways and Transportation Act, 1997* and for which there is a plan on file in the Ministry of Highways and infrastructure, the consent of the minister responsible for the administration of *The Highways and Transportation Act, 1997* is first obtained."

AND WHEREAS approval from the Minister of Highways and Transportation is not required as the streets and lanes are not a public highway that provides continuity to a provincial highway;

AND WHEREAS the Council of the City of Moose Jaw has heard from persons who claim that their lands may be injuriously affected by the closure of the said portion of the attached list of lanes and streets and portions thereof or whom have petitioned the Council to be heard;

AND WHEREAS it is deemed desirable and in the public interest to close the said portions of lanes and streets:

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF MOOSE JAW ENACTS AS FOLLOWS:

Closure of lanes and streets

- 1 The following streets and lanes as listed in Appendix A and subsequent map as shown as Appendix B are hereby closed.

Title conveyed to City

- 2 The Minister of Highways and Transportation for the Province of Saskatchewan be and is hereby requested to convey Title for the lanes and streets to the City of Moose Jaw.

Coming into force

3 This Bylaw shall come into force and effect upon the passage thereof.

READ a first time this 13th day of February 2023.

READ a second time 13th day of February 2023.

READ a third time this 27th day of February 2023.
